Personal data processed by Sandra Bonestroo

Sandra Bonestroo processes personal data for what purpose and on which basis

Basis

How long does Sandra Bonestroo store personal data?

Sharing personal data with third parties

Sandra Bonestroo shares your personal data with third parties if this is necessary for the execution of the agreement and to comply with any legal obligation.

Analytics website visit

On the website of Sandra Bonestroo general visitor data is kept, including the time of retrieval and data that your browser sends. This information is anonymized and will not be provided to third parties.

Google Analytics
